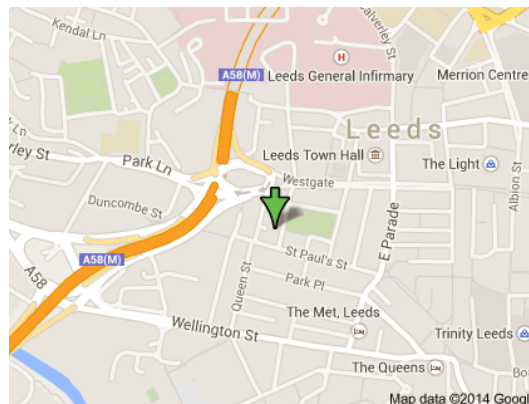

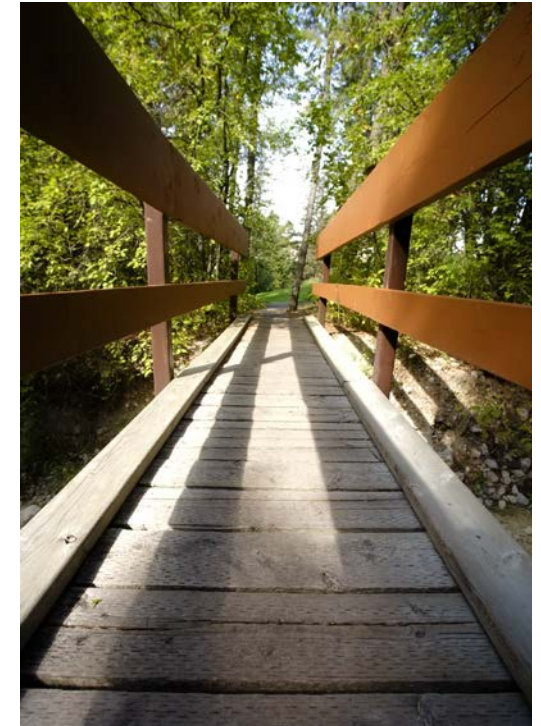

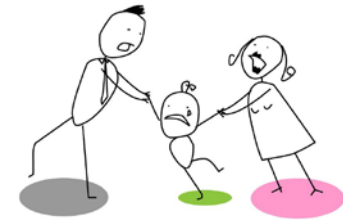
Under the Child Arrangements Programme and in Financial Remedy cases you are required to attend a MIAMS appointment before issuing a Court application save in exceptional circumstances.
